To Arms!! 450 Years of Military History of St. Augustine

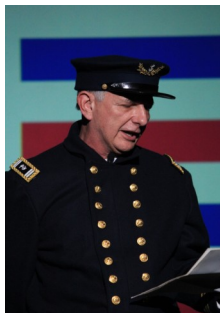
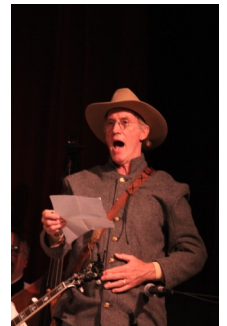
On Thursday evening, February 16th, the 450 Years of Military History of St. Augustine was presented at the Flagler College Auditorium.

For nearly 450 years, St. Augustine has hosted military forces under a variety of flags. In 1565, the Spanish called the first muster of citizen soldiers in North America. Next, the British and Hessian troops, based in St. Augustine, held back American invasions during the War of Independence. Following that Spanish troops defended the town from invading Americans during the Patriot War.

When Florida became a U.S. Territory, Americans had to secure the town from Seminole attack. During the 1860's. St. Augustine was held first by the Union, then the Confederacy and then again by the Union. Though the flags flying from the ramparts have changed, the Castillo San Marcos has never fallen in battle.

Since its founding, military forces have been constantly present in our city. This fact has allowed St. Augustine to remain the oldest continuously occupied European settlement in North America.

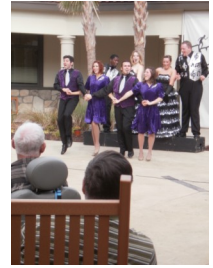

Marine Corps League, Oldest City Detachment #383, St. Augustine, Florida, December 17, 2011

A handful of days before Christmas Day, 2011, your local Marine Corps League gave Christmas to 630 local needy children!

Whatever the Marines do, they do it well, and this past Christmas was no exception. The goal of "Toys for Tots" is to deliver, through a new toy at Christmas, a message of hope to the less fortunate youngsters that will assist them in becoming responsible, productive, patriotic citizens. On December 17th, last year, this act of generosity and kindness was on display by your local Marine Corps League. Doors at the Elks Lodge, St. Augustine, officially opened at 10:00 that morning; however, Moms and Dads with their children were lined up all the way to the back of the parking lot since 6:30am waiting in anticipation. In total, 630 kids walked away with a smile from ear to ear.

When the kids entered, they were immediately given a cookie and a diet drink. Next they had their pick of a game before entering the big

room. Entering this room is where you see their "eyes light up." There were dolls of all description, bicycles, remote controlled cars & trucks, two foot tall stuffed (there were smaller ones too) animals, skateboards, balls of all types, and other toys only your imagination can think of. Ages of our youngsters ranged from near newborn to early teens.

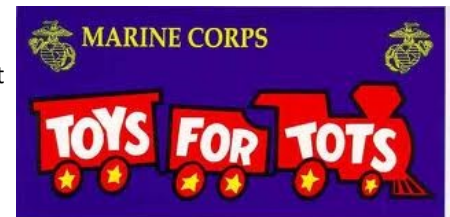
Toys and cash for this fabulous program are donated by local citizens and merchants in St. Johns County. Huge, well marked donation boxes were strategically placed throughout the county that had to be emptied often. The logistics of collecting and storing these toys is no small feat, but the Marines, as usual, did it. Our citizens and local merchants responded well as there were literally thousands of donated toys that ran into the thousands and thousands of dollars.

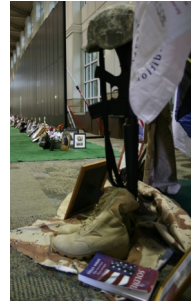

The Traveling Vietnam Wall



For the past 3 years FVPPI (Florida Veterans Programs & Projects, Inc.) hosts an annual "Honoring Veterans" event the weekend before Veterans Day in November. From 2007 through 2010 the event was held at the Flagler College Auditorium. Last November FVPPI switched venues to the larger Anastasia Baptist Church. By all accounts this event, honoring our local ex POWs, was a huge success. One of our highlights at that show was the *Traveling Vietnam Wall*. The Wall is brought into St. Johns County under motorcycle escort and Vietnam veteran Thomas Twigg maintains the Wall.



As a member of the 101st Airborne in Vietnam, Thomas Twigg did his duty and completed his mission. Now this disabled veteran and his wife, Dee, have a personal mission. The Twiggs intend to bring the Vietnam Veterans Memorial Wall to people all over the country who cannot travel to Washington, D.C. For the Twiggs, it is imperative that all veterans and their family members have the opportunity to seek some closure in return for answering the call of duty. Financial and physical hardships should not hinder this.

To fulfill this mission, Tom and Dee have constructed a replica of the Wall that stands 8-feet tall and 46-feet long. The scaled size allows it to be displayed indoors as well as out. And, because the names are closer together, despite the smaller size, the impact is huge. "It hits you all at once," says Tom. "It brings back the reality of what it cost us to be over there."

The Central Florida residents have been traveling since 1995, displaying their replica Wall at community events, schools, VA Hospitals and other locations.

- **Free Lifetime Military Entrance Passes to Florida State Parks for honorably discharged United States veterans who have service-connected disabilities.**

• Proof of identification, service-connected disability, honorable discharge and veteran or retired military status are required. Satisfactory written documentation to prove eligibility includes: Personal identification (i.e.: driver license) and

- Current official documentation from the Department of Defense, Department of Homeland Security, Department of Veterans Affairs or an appropriate branch of one of those agencies, naming the bearer as having sustained a service-related disability, and
- Most recent DD Form 214, Certificate of Release or Discharge from Active Duty, showing the named individual's Character of Service as Honorable, or
- Other current official documentation from the Department of Defense, Department of Homeland Security, Department of Veterans Affairs or an appropriate branch of one of those agencies, naming the bearer as veteran, or retired military.

• **Free Lifetime Military Entrance Passes for surviving spouses and parents of deceased members of the United States Armed Forces, National Guard or reserve units of the U.S. Armed Forces or National Guard **who have fallen in combat.****

• Proof of spouse or child having fallen in combat and proof of spousal or parental relationship are required. Satisfactory written documentation to prove eligibility includes:

- Personal identification (i.e.: driver license) and
- The DD Form 1300, Report of Casualty, showing the Place of Casualty was a combat or war zone on the Date of Casualty, the Circumstances indicate that the casualty was due to enemy action and the Interested Person/Remarks indicates the bearer is the spouse or parent of the military member who has fallen in combat, or
- The final DD Form 214, Certificate of Release or Discharge from Active Duty, showing the date of death as the same date as the date of separation, and
- A marriage certificate or license, birth or death certificate, or adoption papers showing the bearer as the spouse or parent of the military member who has fallen in combat.

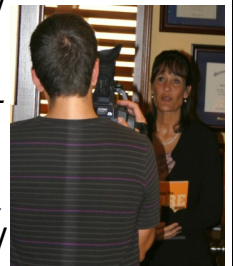

A Marine Sergeant wrote this in response to an army guy who posted a comment on the Marine Corps site that he was sick and tired of "Marine arrogance".

The Sergeant says...

"I think that's what makes Marines special, if only in our own minds, is that elusive Quality of Esprit De Corps. It's the fact that we, as individual Marines, don't feel that we are individual Marines. When we wear our uniform, when we hear our Hymn, when we go into battle, we are going with every other Marine who ever wore the uniform.

Standing behind us are the Marines who fought during the birth Of our nation. We're standing with the Marines who fought in WWI and gave birth to the legend of the "Tufel Hunden", or "Devil Dogs". We are standing with the Marines who took Iwo and Tarawa and countless other blood soaked islands throughout the Pacific.

We are standing with the "Frozen Chosin" and our beloved Chesty Puller. We are standing with the Marines who battled at Hue City and Khe Sanh and the muddy rice paddies of South East Asia. We are standing with the Marines who fought in Desert Storm and Iraqi Freedom and now, are fighting in Afghanistan.

Like real brothers, their blood courses through our veins, and when we go into battle, we would rather lay down our lives than be a disappointment to them.

We carry on our backs, their legacy, their deaths and their honor. We carry that for the rest of our lives.

The Marines Corps uniform doesn't come off when our active duty is over. We wear it daily in our attitude, and our love of Corps and country. We wear it on our tattoos and our bumper stickers. We wear it in our hearts.

It's why, no matter where we are in the world, on November 10th, every Marine celebrates the Marine Corps birthday. It's why we'll never be an army of 1. It's why we never stop being Marines. It's why, for most of us, being a Marine isn't something we were. It's something we are.

It's the most important part of who and what we are. Some say we're arrogant. We say we're proud. We have a right to be proud. We are the United States Marines, the most feared and ferocious group of warriors to walk the face of this earth.

When Americas' enemies formulate their battle plans, they plan on going around Marine units, because they know d-mn well that they can't go through them. We are what other branches wish they were.

We are the modern day Spartans. This isn't bragging. It's written in the battle history of our country. When there's a parade and the Marines march by, everyone pays a little more attention. Some say "arrogance". We call it "pride". It's why, in a crowd of service men, you can always spot the Marine. Why are Marines special? I don't know. We just are.

Coquina Crossing Troop Support by The Coquina Veterans

The Coquina Veterans is an extremely active St. Johns County organization with 80 veteran members. These veterans cover the span of WW II, Korea, the Cold War Era, Vietnam, and Desert Storm. The Coquina Veterans directs its activities towards its membership first, and then, secondly, it has taken on an outside project called "Coquina Crossing Troop Support", or simply "Troop Support."



The military provides daily basic needs for our men and women in uniform; however, it's a misconception everything is provided. Then, Patty Worsham, a Coquina Crossing resident, approached the Coquina Veterans with a concept on how to make the life of our combat men and women in Iraq and Afghanistan more pleasant, even if just a little. The Coquina Veterans agreed. Patty, then singlehandedly, spearheaded a humanitarian effort to gather and ship parcels of those little niceties of life that you and I take for granted. It's things like dental floss, chewing gum, shampoo, finger nail polish, beef jerky, magazines, cheese & crackers, and on and on and on. The name of this program became "Troop Support."

Troop Support quickly blossomed from concept to actuality. At first, the number of parcels shipped were few, but it quickly grew to a couple dozen a month. Because the concept was so solid, Patty had little problem obtaining the merchandise needed from our local businesses, but the logistics of storage and getting the boxes packed and labeled for shipment became an issue. So, 'packing parties' were developed whereby members of the Coquina Veterans and community residents stepped forward to help. Of recent, the number of monthly shipped parcels has lowered; however, since October, 2006, over 1,100 parcels have been packed and shipped to the front lines in Iraq and Afghanistan. These parcels represent over 12,000 pounds of merchandise with a shipping cost exceeding \$11,000.



Patty wasn't done. Through her communications with service personnel connected to the front lines, she learned two more things were needed. First, for those cold winter nights in the innermost mountainous reaches of Afghanistan, watch caps were needed to keep the head and ears warm. A group of Coquina Crossing ladies called the "Madhatters" answered the question by getting together to knit caps. Over 300 caps for both our troops and village children were hand knitted and shipped through Troop Support.

Second, it was learned many of the badly wounded were cold while enroute from battlefield to hospitals in Landstuhl (Germany) and Walter Reed. So, another group of Coquina Crossing ladies gathered to make quilts to warm these wounded warriors while in transit to hospitals. Each quilt is hand made and autographed by the maker. There were over 65 quilts made, and each wounded Marine or soldier gets to keep that quilt for life.



You might ask, "Where does all the money come from?" Strictly donations! Local businesses have been very generous and for the past 3+ years, the Coquina Veterans have picked up the shipping tab. But more is needed, and donations are gladly accepted as this program is ongoing.

Donations are accepted through a tax exempt corporation called Florida Veterans Programs and Projects, Inc., a creation of Michael Rothfeld, another Coquina Crossing resident. Although this 501-c-3 not-for-profit corporation was not created expressly for Troop Support, it became an excellent financial means to funnel Troop Support donations. Because of this corporation's tax exempt status, all donations are tax deductible.

It's easy to see that although Patty and the Coquina Veterans have put Troop Support together, it is a total community effort. Without the support and blessing of the residents of Coquina Crossing, this program would not have reached the level of success achieved. For that, the patriotic citizens of Coquina Crossing are to be thanked.

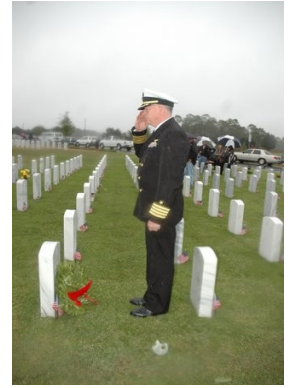

**CLARIFICATION ON FLAG PRESENTATION
DURING MILITARY FUNERAL HONORS**

PURPOSE:



To debunk a recent rumor of changes to the script used during the presentation of the US Flag during MFHs

BACKGROUND:

There have been several rumors recently of changes to the script used during the presentation of the US Flag during Military Funeral Honors (MFHs). These rumors are completely false, as there have been no changes to the script.

GUIDANCE:

AR 600-25 (Salutes, Honors, and Visits of Courtesy) refers to FM 3-21.5 (Drill and Ceremonies) for execution of Funerals.

Chapter 14-5q and 14-6d state: Upon presentation, the CAO renders appropriate remarks such as, "Sir/Ma'am, this flag is presented on behalf of a grateful nation as an expression of appreciation for the honorable and faithful service rendered by your loved one."

The DA Pam 638-2, para 10-11(b(1) states with regard to presentation of the FLAG CASE: "This flag case is presented on behalf of the Secretary of the Army ..."

CMAOC strongly recommends following the FM script during MFHs to ensure standardization.

Be advised that the Office of the Secretary of Defense (OSD) is developing a script to be used by all Services for MFH flag presentations, but it is not expected to be finalized until mid year 2012 at the earliest. Additional guidance will be provided by CMAOC once the OSD script has been released.

1st Lt. Tom Waskovich, 1969 Vietnam, (St. Augustine Beach)

The article below is an excerpt from the book, "Running Recon", by Frank Greco and details the actions of a key operator on the first Top Secret mission to block the Ho Chi Minh

Trail in 1969. **Lt. Tom Waskovich** was the commander of the SOG Commando team that was on Bright Light duty at that time. (Bright Light was the code name for a SOG team that was on duty for 7 days, 24/7, and had the mission to rappel in on top of SOG teams that ran into trouble and reinforce them, and/or to rescue air crew from aircraft that were shot down).

This is one of the most successful SOG missions and Lt. Waskovich played a key role in destroying 6 NVA trucks with a recoilless rifle and an M60 machine gun.

Operation Nightcap/Spindown

Operation Nightcap occurred in the third week of March 1969. Hatchet Force Company A was helicoptered into Laos under heavy air support and secured a small hilltop overlooking Highway 110, the two separated by a small river named the Dak Xou, Company A troops had brought a 90mm recoilless rifle with them to knock out trucks trying to sneak past them at night. However, intense barrages of enemy machine gun and mortar fire kept them

down for most of the night. Among the many who were wounded was the recoilless rifleman, for whom they needed a replacement. **1st Lt. Tom Waskovich**, the One-Zero of RT South Carolina, was on Bright Light duty at Dak To, and when he heard someone was needed to operate the recoilless rifle he volunteered to go in.



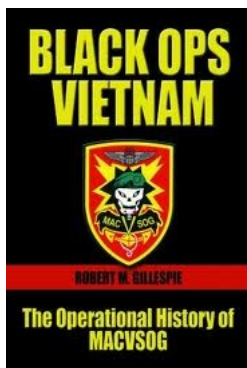

Once in, they soon realized that the enemy was using the barrage of fire to keep the Hatchet Force's head down as trucks sneaked past their location. Waskovich was able to spot one of the trucks sneaking past at night and nailed it with the recoilless rifle, blocking the road and backing up trucks behind it, turning them into additional targets for the recoilless rifle. Shortly after that the Hatchet Force used a Starlight scope to spot the NVA

trying to fill the bomb craters on the road and get the destroyed trucks off the road, and then raked them with .50-calibre machine gun fire. Eventually the number of casualties forced the Hatchet Force to be extracted, but not before inflicting heavy casualties on the enemy by direct fire and air support and putting a serious crimp in the supplies moving across that part of the Trail. A week later Operation Spindown went into the same location with similar results.

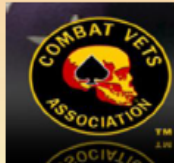

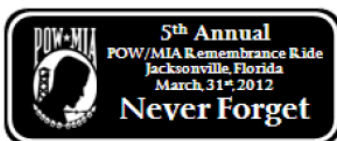

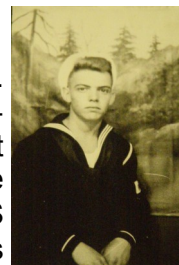

Unveiling of the USS Houston CA-30 Model a Big Success



On 17 November 2011 USS *Houston* CA-30 Survivors David C. FLYNN, Howard BROOKS, and Bill INGRAM, as well as former crewman Ray KESTER were among the over 80 people who gathered at the National Museum of the US Navy in Washington, DC to celebrate the installation there of a magnificent 14-foot-long scale model of USS Houston CA-30. After a special ceremony, attendees applauded as

mounted lights blinked on inside the new case for the first time in public, illuminating the beautifully restored 1929 model of USS *Houston* CA-30 by renowned model builder Horace E. Boucher. Ed Furgol, Director, Naval History and Heritage Command provided speaker introductions at the installation ceremony. Speakers included: RADM Jay DeLoach, USN (Ret.); Royal Australian Naval Attaché LCDR Carl Holmes, RN; Dana Wegner, Curator of Ship Models, Naval Sea Systems Command; and our Association's Executive Director John Schwarz. Built around 1929 in New York City by the highly acclaimed H. E. Boucher Manufacturing Company, the wood and brass model today is a part of the collection of the Naval Sea Systems Command, which includes some 2,500 ship models, Mr. Wegner explained. Horace Before its installation in the museum, the model had been moved several times. Beginning in 1961, the Navy loaned Boucher's model to the BB USS *Texas* in Houston, Texas. While there, it was damaged, and its case was lost, Wegner said. Boucher had been lead model maker at the Washington Navy Yard until 1905, when he resigned and founded a model production firm which developed a reputation as the top model-building studio in America, Wegner said. The *Houston* model is now one among several of the best examples of Boucher's work at the National Museum of the USN, which displays it in the Pacific section, “In Harm's Way: The US Navy in World War II” exhibit. According to Wegner, “(Back in 1929) it probably took three model builders one year to complete.” The 3-man team that had worked under Wegner to recondition the model took some 1,100 man hours to completely disassemble, repair, repaint, and re-rig the *Houston* to bring it back to its original condition, Wegner said.

In 1996, the model was brought into storage at the Naval Surface Warfare Center in Bethesda, MD. Association founder Otto Schwarz and Wegner discussed a plan to recondition the model back then, but the idea became dormant, Wegner explained. It wasn't until June 2010 when Otto's widow, TRUDY SCHWARZ alerted her son JOHN SCHWARZ to one of Otto's old files. (Otto Schwarz died in 2006.) John Schwarz contacted Wegner and “enthusiastically picked up where his father had let off some 14 years earlier,” Wegner said. “Ethically bound,” Wegner and his team of model restoration experts “were careful to preserve Boucher's intent, and except for the flag at half-mast, it looks exactly like it did when the US Navy obtained it in 1929,”

Wegner explained. “We were inspired by the sentimental role the model plays commemorating those lost aboard gallant *Houston* in 1942, and by the model's symbolic role in the minds of the survivors and next generations. This model has a soul,” Wegner said. In an email, Mr. Wegner further discussed the unique significance of the *Houston* model's flag. “While a few times we have mounted flags at half-mast for ships lost, the USS *Houston* model is the only one at the Navy Museum. As far as I can tell, the half-mast tradition began when the Navy displayed our model of the USS *Maine* in the Capitol rotunda in February 1898.” USS *Houston* family in attendance included: Ann DuHaime, Teresa REILLY, Trudy SCHWARZ, David and Donna FLYNN, How-

What a glorious affair the unveiling was! The Navy planned out a very nice tribute program including many military protocols, the model unveiling itself, then a professionally facilitated "round table" where our survivors and shipmates in attendance (Ingram, Flynn, Brooks, Kester) were able to speak to the audience on various topics from recollections of their own personal experiences. It was a fascinating program with which everyone seemed overwhelmed. For those who could not make it, we will provide ample visual coverage at our upcoming reunion. I would like to express to you how honored I was to be able to speak on behalf of our organization at the ceremony. The entire effort was a true team accomplishment that clearly demonstrates what we can do when we properly pool our collective talents, effort, hearts and souls into something so directly related to our Association's mission. Major initiatives such as this do require our collective efforts. Anyone anywhere near the Washington D.C. area must come and see the model. You will be very happy you did! Florida Exempt Organizations Filing Deadlines

The IRS requires organizations exempt from federal income taxation to file annual returns. Depending upon the organization's gross receipts (not net receipts or net surplus/deficit), each public charity must file Form 990 by four and one-half months after the end of their fiscal year (May 15th for calendar year filers):

- * 2011 Gross Receipts are normally \$50,000 or less, create an account then file form 990-N at <http://postcard.form990.org/>
- * 2011 Gross Receipts normally more than \$50,000 but less than \$200,000, with total assets less than \$500,000, may file [form 990-EZ](#) or [form 990](#)
- * 2011 Gross Receipts normally more than \$200,000, or with total assets more than \$500,000, must file [form 990](#).

In addition to filing forms 990-EZ or 990 (but not 990-N), certain schedules must be completed (bold items are frequently required of Veterans' exempt organizations):

A. Public Charity Status and Public Support

- B. Schedule of Contributors (most often, retained with workpapers, but not filed)
- C. Political Campaign and Lobbying Activities
- D. Supplemental Financial Statements
- E. Schools
- F. Statement of Activities Outside of the U.S.

G. Supplemental Information Regarding Fundraising or Gaming Activities

- H. Hospitals
- I. Grants and Other Assistance to Organizations, Governments and Individuals in the U.S.
- J. Compensation Information
- K. Supplemental Information on Tax-Exempt Bonds
- L. Transactions with Interested Persons

M. Non-Cash Contributions

- N. Liquidation, Termination, Dissolution or Significant Disposition of Assets

O. Supplemental Information to Form 990

- P. Related Organizations and Unrelated Partnerships

2011 Gross Income (not Gross Receipts) from an unrelated business (a trade or business, regularly carried on, that is not substantially related to the charity), file [form 990-T](#) Exempt Organization Business Income Tax Return. For more information, please see [IRS Pub 598](#) and [instructions for form 990-T](#). The exempt organization may also be required to file quarterly [form 990-W](#), Estimated Tax on Unrelated Business Taxable Income for Tax-Exempt Organizations.

Florida requires exempt organizations that solicit funds (other than membership dues) to file [form 10100](#) annually, one year from the date of their initial date of compliance with F.S. 496, with the Florida Department of Agriculture and Consumer Affairs.

[Professional solicitors](#) and [Professional Fundraising Consultants](#) must also register before conducting activities within the state. Filing fees are based upon gross revenues.

To determine the status of your exempt organization, go to Florida's Gift Givers Guide, <https://csapp.800helpfla.com/cspublicapp/giftgiversquery/giftgiversquery.aspx>.

Unincorporated exempt organizations must [register their Fictitious Name](#) with the Florida Secretary of State, and [renew this registration](#) every five years.

Incorporated exempt organizations must [register their corporate status](#) with the Florida Secretary of State, and [renew \(updating their officers, etc.\)](#) annually, before May 1.

While the Florida Secretary of State requires payment of fees at filing, penalties for late filing are not imposed upon exempt organizations. To determine the status of your exempt organization, go to www.sunbiz.org

St. Johns County has a [local business tax](#) that may be levied on exempt organizations having [electronic games](#) or other significant

assets. Tax is due on September 30.

A new online search tool allows users to select an exempt organization and check certain information about its federal tax status and filings.

Exempt Organizations Select Check is an on-line search tool that allows users to select an exempt organization and check certain information about its federal tax status and filings. It consolidates three former search sites into one, providing expanded search capability and a more efficient way to search for organizations that:

1. Are eligible to receive tax-deductible charitable contributions (Publication 78 data),
2. Have had their tax-exempt status automatically revoked because they have not filed Form 990 series returns or notices annually as required for three consecutive years (Auto-Revocation List), or
3. Have filed a Form 990-N annual electronic notice (e-Postcard).

Beginning in February 2012, Exempt Organizations Select Check data will generally be updated on the third Monday of each month for automatically revoked organizations and organizations eligible to receive deductible contributions, and weekly for Form 990-N (e-Postcard) filings. In addition to searching for a particular organization, users may download a complete list of each of the three types of organizations through Exempt Organizations Select Check.

Treasurers' & officers of all exempt organizations should go to <http://apps.irs.gov/app/eos/> to verify items 1 and 3, and that their organization has not had their tax-exempt status revoked. After clicking on the above link, click on each button (described in 1, 2 & 3 above) to search for your organization. Ideally, 1 & 3 should report your exempt organization, and 2 should fail.

Search criteria include the Federal Employer's Identification Number (FEIN), Name, City, State, Country and deductibility status—most should be "PC" for Public Charity. Click on the highlighted field name for a definition of that field's data.
