The evening of June 9 was an incredible evening. For those who attended this years Battle of Midway Commemorative Dinner had the opportunity to witness some of this nations greatest living heroes. This year we were fortunate to have 16 Battle of Midway Veterans attend along with 4 Midway Veterans widows. Medal of Honor recipient Robert Ingram was again our special guest as was 12 former POW's, 17 Wounded Warriors and numerous other Veterans from the Battle of Normandy. The event also recognized Veterans from the Korean War, Vietnam War, and the current Global War on Terrorism.

The guest speaker for the evenings event was Admiral Mark Ferguson, Vice Chief of Naval Operations. His message discussed the similarities between the bravery displayed by these special Veterans during the Battle of Midway to the heroics of the servicemen and women now serving in conflicts abroad. Admiral Ferguson also provided a "State of the Navy" by providing an overview of the current operations and how our brave warriors are doing more with

less and continue to bring the fight to the enemy. Following Admiral Ferguson's remarks, a special gift was presented to each Battle of Midway Veteran by the Admiral as Master of Ceremonies Arthur Crofton read aloud their bios. It was a very moving occasion.

Following the Admirals keynote speech and the Battle of Midway Veterans awards, the POW's were recognized as Arthur Crofton read each ones harrowing experience as a captive and internment in a POW camp. Each POW Veteran received a thunderous standing ovation from the 831 attendees as their months and years in captivity were told by our Master of Ceremonies.

Other Veterans including our Wounded Warriors were recognized for their service and all were applauded appreciatively by those attending.

The pageantry and attendance is unmatched anywhere in the country in honoring our Battle of Midway Veterans. The Navy League Council at Mayport is in its 15<sup>th</sup> year of celebrating and honoring these Veterans. This being the 70<sup>th</sup> anniversary of the turning point battle of the Pacific, it was a very special occa-



sion. As I have become personally acquainted with many of these BOM Vets, each of them have told me this is the highlight of their year and they look forward to it with anticipation all year.

This year for the first time we had an essay contest with JROTC and Sea Cadets participating. The first place winner from the Sea Cadets was PO3 Luke Mahan from the St. Augustine Battalion, NSCC . First place winner from the JROTC was Cadet Nicole Thatcher, NJROTC- Nease High School. Each cadet received a \$1000 scholarship.

Another highlight of the evening was young 12 year old Faith Miller as she sang "You Are Our Heroes" to our Veterans and at the conclusion of the evening, she sang Lee Greenwoods "God Bless The USA" accompanied by a male vocalist and the Southeast Region Navy Band.

The 95,500 square foot veterans' home, which opened in September 2010, incorporates extensive land-scaping, recycled materials in its construction and uses less water and energy than conventionally designed facilities. It is also a tobacco free campus for residents, staff and visitors.

SUBJECT: Establishment of Uniform Military Funeral Flag Presentation Verbiage

Effective immediately, flag presentation verbiage for military funeral honors ceremonies conducted by the Department of Defense will be standardized. The following verbiage will be used when presenting the American flag during the funeral service:

"On behalf of the President of the United States, (the United States Army; the United States Marine Corps; the United States Navy; or the United States Air Force), and a grateful Nation, please accept this flag as a symbol of our appreciation for your loved one's honorable and faithful service."

The Under Secretary of Defense for Personnel and Readiness will ensure that this guidance is incorporated in the next revision of Department of Defense Instruction 1300.15, "Military Funeral Support." The United States Coast Guard is invited to use the same verbiage.



#### **Veterans' Nursing Homes of Florida**

Any person interested in residency can be referred through a <u>VA Medical Center</u>. Candidates must be veterans with qualifying war or peacetime service, be a resident of Florida for one year immediately prior to applying for admission and must require long-term care in a skilled nursing facility. For <u>admission information</u> you may contact the nearest <u>County Veterans Service Office</u> or <u>FDVA Service Office</u>. Veterans with service-connected disabilities or veterans unable to afford nursing home care will be considered first for residency. You are welcome to contact the Admissions Coordinator for the Home in which you are interested for additional information. Tours are always available.

#### Purpose:

To provide skilled or intermediate type nursing care and related medical care in VA or private nursing homes for convalescents or persons who are not acutely ill and not in need of <u>hospital care</u>.

#### **Admissions Criteria:**

The State Veterans' Nursing Home at Daytona Beach, Land O' Lakes, Pembroke Pines, Port Charlotte, Springfield and St. Augustine have the following general admissions criteria.

#### The veteran must be:

- (1) a veteran as determined under Chapter 1.01 (14), Florida Statutes.
- (2) a resident of Florida and have been a resident for one year prior to application.
- (3) in need of nursing home care for a condition which requires services which fall within the level of care for which the home has resources and functional ability to provide.



#### From Jim Vanairsdale, LTC USMC, ret.

June marks the 62nd anniversary of the outbreak of the Korean War, a three-year conflict that claimed 4 million lives, over 36,000 of them American. Their selflessness and sacrifices have gone unnoticed for too long.



No time between June of 1950 and July of 1953 was a "good" time to serve in the Korean War. Combat veterans who fought in the deadly outpost wars in 1953, who dug in to hold strategic hills in 1952, who chased the Communist enemy back north in 1951, and who held perimeters in the early days of the war in 1950 - each had to endure their own unique hardships, as well as fight overwhelming numbers of enemy troops. The entire Korean War was a series of cold, bloody and forgotten events and battles that claimed many lives. To this day, not all of our war dead and missing have been returned.

In February of this year, I travelled to the Marine Expo West held in Camp Pendleton and while there visited a booth hosted by the Department of Defense 60th Anniversary of the Korean War Commemoration Committee. Since last year, events have been held by "KW60" in many states to thank and honor all the Veterans of the Korean War. Also under this program, Korean War Veterans can register to receive a personalized Certificate of Appreciation signed by the United States Secretary of Defense. Locally, veterans registered and their service was honored at recent gatherings.

Please disseminate the "KW60" information so that those who served during this "Forgotten War" can be given honorable recognition for their service. The veteran is a relative, a friend, a neighbor or someone you meet at the grocery store. So when you meet them, be glad that you are

privileged to live in this Country and proud to be an American. Our military is the reason we have this amazing Country in which we live. They will always be the reason.



#### KOREAN WAR

On June 25, 1950, North Korea launched a surprise attack as its troops crossed the 38th parallel and invaded the Republic of Korea and the United Nations Security Council unanimously condemned this invasion.

This action of aggression ignited an epic struggle between the forces of freedom and democracy and tyranny and despotism. On, June 27, 1950, the Security Council recommended member states provide military assistance to the Republic of Korea. The same day, President Harry S. Truman ordered U.S. air and sea forces to help the South Korean régime announcing that the U.S. would counter "unprovoked aggression" and "vigorously support the effort of the Security Council to terminate this serious breach of peace." In 1948, President Truman had already signed an Executive Order securing the full integration of America's Armed Services. Thus, America went to war in Korea for the first time in her history with a military that reflected her diversity.

The Korean War was the first test of the United Nations' resolve to stand against tyranny in all its forms. Many Nations banded together with the United States and South Korea in a remarkable display of solidarity to turn back naked aggression and stem the tide of communism.

The goal of the Chinese and North Koreans was to completely annihilate their enemy. They failed in their mission. Instead, allied troops displayed great tenacity and determination as they fought their way causing tremendous enemy casualties in the process. Amazing feats of accomplishment and endurance took place. Against overwhelming odds, including massive numbers of enemy and extreme cold temperatures, allied participants succeeded in avoiding annihilation by fighting their way out of deadly traps set by the Communist enemy. Meanwhile, thousands of U.S. Navy personnel miles away at sea were involved in close air support efforts for the ground

forces. As one Navy veteran commented, "I did not have anyone shooting at me, but I assure you it was just as cold 25 miles out to sea as it was in the hills and valleys of Korea."

In the United States, the war was initially described by President Harry S. Truman as a "police action". It has been referred to in the United States as "The Forgotten War" or "The Unknown War" because the issues concerned were much less clear than in other conflicts, such as WW II and the Vietnam War.



The Korean War was a victory for the United States and the United Nations. The Armistice ending the war was signed on July 27, 1953, and remains in effect today to remind us that we must remain vigilant against the forces of tyranny and oppression.

We must never forget the selfless sacrifices of those who fight to ensure the freedom and prosperity we enjoy today. Our troops set aside their own comfort, safety and aspirations to answer the call to arms, and at a time when our Nation was still exhausted from the horrors of World War II. The Korean people know that their survival and subsequent prosperity is nothing shy of a miracle, and they have never forgotten that if American President Harry S. Truman had not made the decision to send American soldiers when the Korean War broke out, the Republic of Korea might not even exist today. Today the Republic of Korea stands as a modern, prosperous, vibrant democracy because of the courage and selfless sacrifices of our Military. Their spirit is alive and strong. They shall not be forgotten nor was their death in vain.

#### KOREAN WAR COMMEMORATION

In the 2011 Defense Authorization Bill, the Department of Defense 60th Anniversary of the Korean War Commemoration Committee was authorized. The goal of this Committee is to thank and honor Korean War Veterans for their service and sacrifice on behalf of the United States, including members of the Armed Forces who were held as prisoners of war or listed as missing in action, and to pay tribute to the sacrifices and contributions made on the home front by the people of the United States - their families and especially those who lost loved ones in that war. Another goal is to commemorate the key events of the war and educate Americans of all ages about the historical significance of the Korean War. Organizations all across the Nation can be part of this effort to pay tribute to these heroes.

#### GUARDIAN ANGELS MEDICAL SERVICE DOGS PARTNER WITH VA HOSPITAL TO HELP PTSD VETERANS



Guardian Angels Medical Service Dogs, Inc. is partnered with the federal government to provide highly trained, federally protected service dogs to

the Veteran's Administration (VA) in a pilot program examining the impacts that service dogs have on veterans with post-traumatic stress disorder (PTSD). These dogs are trained to mitigate the challenges of PTSD.

With an estimated 400,000 veterans currently in treatment for PTSD, 40,000 of them with other disabling injuries (according to the US Department of Defense) and an additional 33% of our soldiers are expected to return with PTSD, addressing the mental and physical health needs of these veterans can be an overwhelming challenge for both the veteran and their caregivers. Just in this group of veterans alone, there are 39 suicide attempts on a daily basis with 18 – 22 resulting in death.

Service dogs have long been paired with the physically disabled to restore independence to recipients. The current study, led by medical personnel from the James A. Haley Veterans' Hospital of Tampa, Florida, is expected to officially quantify the specific benefits that service dogs afford veterans with PTSD.

During the two-year study, up to 230 qualified Veterans currently in treatment for PTSD will be permanently paired with highly skilled service dogs custom trained to assist with their individual challenges. Veterans will assume responsibility for their service dogs' daily care during the study period and beyond. At the end of the study, the results will determine at what level service dogs mitigate issues that PTSD veterans face on a daily basis. If the results document significant benefits – as anticipated – it will pave the way for veterans across the country to also receive a service dog and have their lives restored.

While this is not a cure, the results have been nearly immediate and amazing in the Veterans that have been paired with their service dogs so far. Where medications and therapy have not been enough, these dogs seem to be the missing link in restoring the broken lives of our veterans and their families.

Guardian Angels Medical Service Dogs, Inc. is a 501(c)(3) non-profit organization located in Williston, Florida that trains highly skilled medical service dogs to assist the mentally and physically disabled with everyday tasks that they would otherwise not be able to do without a caregiver. There are no federal grants for the work we do, nor does insurance cover medical service dogs. We can only continue to help these people through corporate sponsors, private grants and fundraisers.

## The Jacksonville Ladies

of the Jacksonville National Cemetery

In September of 2008, a new volunteer service was formed for the Jacksonville National Cemetery. At the Dedication Ceremony the Jacksonville National Cemetery Advisory Committee suggested that

local women's organizations take on this "Last Tribute" to our Veterans that will be buried in the cemetery. The Jacksonville Ladies started meeting in November 2008 and participated in the first internments that began in January 7, 2009. This non-profit volunteer program shadows the Arlington Ladies, a volunteer group of military wives and lady veterans at Arlington National Cemetery in Arlington, Virginia, whose service began in 1948.

Veterans with no family in attendance are of particular concern and the Jacksonville Ladies are present when family or friends are unable to attend the services to ensure no Veteran will be buried alone. The intent of participation by the Jacksonville Ladies is strictly not to interfere with funeral services, but rather to support any Veteran or Veteran's widow or family during a time when they feel the loss of a loved one. One Jacksonville Lady is represented to honor and attend each Veterans service at the cemetery as requested by the family. A condolence card is presented to the families and the Jacksonville Ladies affirm that they are there to assist, accompany and promote a sympathetic relationship with Veterans and their families.

Membership and participation in the Jacksonville Ladies is strictly voluntary and not limited to military service related women and is not connected to membership or participation in any other affiliation. Members are obtained through word of mouth and participants volunteer for specific dates depending on their availability with morning and afternoon shifts available. Up to four volunteers may be assigned to a specific date to cover the possibility of multiple funeral services running simultaneously.

The first service may begin as early as 8:30 a.m. and services can take place every thirty minutes with the last service ending by 2:30 p.m. from Monday through Friday. There is no minimum or maximum number of times a volunteer may participate; however, training is mandatory before being put on the schedule. The Jacksonville Ladies wear a uniform consisting of a navy blue suit with a patriotic collar or flag pin and a Jacksonville Ladies nametag at all services and events so they can be clearly identified. Volunteers demonstrate a sincere desire to support Veterans and their families, and exhibit a willingness to honor those who have served this nation.

The Jacksonville National Cemetery is located north of the Jacksonville International Airport at 4083 Lannie Road in Jacksonville, FL and is just a few miles off of I-295 and Lem Turner Road. 

Our guest speaker will be Michael Hingson author of the Best Selling book Thunder Dog. Here is a little about Michael:

When the World Trade Center was attacked on 9-11, it was as though the world stood still. It was a day that captured our full attention. Michael Hingson and his Guide Dog Roselle were on the 78th floor of Tower One that day, and were able to make their way to safety and survive the attack. The duo was immediately thrust into the international spotlight, becoming well-known representatives of the strength of the human/animal bond and a living example of the powerful partnership that exists between a blind person and their Guide Dog. In 2002 Michael joined the Guide Dogs for the Blind team as the National Public Affairs director, to share his story throughout the world on behalf of the school. In June of 2008 Michael left Guide Dogs to form The Michael Hingson Group to continue his speaking career as well as to serve as a consultant for corporations and organizations that need assistance with Inclusive and Diversity training as well as adaptive technology training.

Michael Hingson is available for speaking engagements, public appearances, consulting and training contract positions and media interviews. In his own words:

I lived through the 9-11 tragedy and have much to say about my experiences leading up to and escaping from the terrorist attacks on the World Trade Center. Since that day, I've traveled the world with Roselle and her successors; at first to help people heal and hope, and now, to help them find meaning and purpose. As a blind person living in today's world I want people to see that while there are many different kinds of people, each with their own different gifts, we all can live and work together if we choose to open our minds and hearts and become a more inclusive world. There are positive lessons to be learned from every tragedy, and 9-11 is certainly no exception.

Because I am blind, I have a unique perspective. Because I believe in the power of partnering with my Guide Dog, I can speak from the heart about teamwork and trust. I've been a guest numerous times on Larry King Live, have been interviewed on Regis and Kelly, and have appeared on the CBS Morning Show. Come meet and hear Michael as he engages all our fantastic veterans.

Once a Marine, always a Marine. And you don't have to be a U.S. Marine.

Tim Chiu died Saturday, May 12th at 77 of leukemia. He was the owner of A1A Hardware in St. Augustine, an associate member of the Marine Corps League, the Kiwanis Club and a man whose American dream came true.

"He came from nothing," his daughter Dorothy Chiu said. She knows from visiting the home in Taiwan where her father was born and raised as Chiu Yao Tyng.

"A family of five in a 10-by-10 room," she said. "It really humbles you and makes you appreciate what you have here."

When Tim Chiu was 18, his father died and he became head of the household that was compressed into that tiny living area, his son Harold said.

His concern became making sure his brothers, sisters and mother were clothed and fed and that he did all he could to keep that meager roof over their heads. He served five years in the Republic of China (Taiwan) Marines and was on Quemoy Island when the Red Chinese shelled it during the second Strait of Taiwan Crisis. The free Chinese returned fire, but suffered far more casualties. America was officially hands-off, but the 7th Fleet patrolled the strait in case the Red Chinese thought of invading.

Tim Chiu studied at the University of London, where he met his wife, Jolande, and they ultimately came to America and became citizens. Although his father was well educated, Harold Chiu said, he always was entrepreneurial and wanted to try something on his own.

That's how a man with a PhD in chemical engineering came to own a hardware store in St. Augustine. When his friend, retired Marine Lt. Col. Jim Vanairsdale, asked why he wasn't in the Middle East making tons of money, Chiu replied, "Money isn't everything."

He was a hands-on, do-it-yourself kind of man, with a generous and kind nature, said the people who knew him. Some spoke of the sweetness of watching Tim and Jolande Chiu taking their daily walks hand-in-hand.

When he got sick about six months ago, his friends gathered around him. Vanairsdale had asked Tim Chiu about wearing his old ROC Marine uniform to a Marine Corps League meeting so everyone could see it. But Chiu said when he left the service, he had to turn in his shirt, his socks, his underwear, everything.

"His wife said he was so poor, he couldn't even afford to have his picture taken in it," Vanairsdale said. "I said I didn't think that was right."

So Vanairsdale set about correcting it. He contacted the Taipei Economic and Cultural Representative Office in Washington, where attache Gary Chao asked for more information. One question showed his eagerness to help a hero of his country.

"What can we do to help Mr. Chiu Yao Tyng? Like providing military uniforms, insignia, etc.?" he asked in an email.

When Vanairsdale had provided all the information, Chao said he was sending the uniform and some other "stuff." Among that stuff was a US-ROC Mutual Defense Commemorative Badge.

Once he got the uniform about a month ago, Tim Chiu put it on for his U.S. Marine friends.

"I haven't seen him that excited in awhile," Dorothy Chiu said.

He also posed in it for a photo with his wife and two of his three children. The Chius' third, daughter Felicia Lo, lives in Alexandria, Va.

"He really liked that uniform," Harold Chiu said. "He understood the effort to get it."

His father knew about effort, always did what he said he would and taught his children the value of hard work.

"He set the bar high," Harold Chiu said. "When I accomplish something, I sometimes quietly say, 'Thank you, father.' "

The next stop in his accomplished life is at the Mayo Clinic in Rochester, Minn., where he'll work as a project manager in biomedical engineering.

We all owe him thanks for what he did in Taiwan and in America.


