


MODEL UNVEILING A HUGE SUCCESS



Parade field becomes consecrated ground by Michael Isam



St. Augustine, Fla, (September 14, 2013) — "But, in a larger sense, we can not dedicate -- we can not consecrate -- we can not hallow -- this ground. The brave men, living and dead, who struggled here, have consecrated it, far above our poor power to add or detract." Abraham Lincoln, Gettysburg Address

Thus Major General Emmitt Titshaw Jr., Adjutant General of Florida, began the ceremony to recognize 448 years of Citizen-Soldier muster and consecrate the St. Francis Barracks parade field at the Florida National Guard Headquarters.

For more than two years soil has been collected from 19 battlefield locations around the world where present day Florida National Guard and its militia predecessors served and fought. Most of the soil came easily and freely being collected by military and embassy personnel. The soil from Kuwait made the trip three times before finally finding its new home here.

The idea came from Senior Army Advisor Col. Dave Rodgers who saw a similar ceremony at Fort Benning, Ga. Rodgers met and discussed the idea with Maj. Gen. Emmett R. Titshaw Jr., and retired Lt. Col Greg Moore, Command Historian for the Florida National Guard. Titshaw gave his approval in 2011 and the daunting task began.

Soil from the 19 locations was spread from mess tins in memory of those who served. "Many of you in the audience today," said Moore, "have probably seen the classic Steven Spielberg movie 'Saving Private Ryan,' and remember the scene shortly after the last German bunker was secured on Omaha Beach where Technical Sergeant Mike Horvath, played by Tom Sizemore, gathers dirt and places it in a ration tin labeled 'France.'" "He then shoves it in a satchel with two other tins labeled 'Italy' and 'Africa.' Sergeant Horvath, like many of his fellow soldiers, wanted to bring back something tangible to remind him of the hard-fought battles he was a part of in three different countries."

Connecting the locations together builds quite an itinerary. Moore gave the following locations during the ceremony.

Begin at the grounds of the present day Fountain of Youth, site of the first militia muster on the North American continent, to the Kanapaha Prairie in mid-Florida during the Seminole Wars. Then after a scant two year rest take a quick jaunt to Vera Cruz, Guadeloupe, and Puebla, Mexico during the Mexican War. The first, but hardly the last time members of the Florida National Guard served outside of the State of Florida.

Switching uniforms to the Confederate States of America travel to Gettysburg, the west bank of Chickamauga Creek, Olustee, and Cold Creek.

Advance forward to 1918 and the First World War, travel to Camp Pontanezen, near Le Mans, France.

Pack your gear, travel to various locations in the continental United States followed by a cruise to western New Guinea in the summer of 1944. From July 10 to August 25, 1944, call the area of the Driniumor River your home. Take a journey to Morotai, a small island in the former Netherlands East Indies. Remember to travel to Mindanao Island in the Philippine Archipelago.

Beginning in August, 1951 deploy to Misawa Air Base in Japan and spend time flying over the landscape

of North Korea.

In late 1990, arrive in Riyadh, Saudi Arabia and travel to two locations in the United Arab Emirates and one in Oman.

After the fall of the Twin Towers, arrive at Camp Phoenix in Kabul, Afghanistan. Spend ten months walking the streets of Baghdad, Iraq with occasional side trips over the border to Jordan.

Find locations such as Turkey, Qatar, Kuwait, Germany, Kyrgyzstan, Iraq and Afghanistan on your itinerary. These are mandatory stops.

While touring those areas, remember Camp Buehring, Kuwait. Witness the last troops leaving Taji at the end of the Iraq war.

There is nothing whimsical meant about the itinerary above. The deployments were real. The citizensoldiers, men and women, paid a dear price for their desire to serve their country. Some paid with their lives, others paid in a myriad of ways. Always remember, "For those who have fought for it, freedom has a flavor the protected will never know."

Many of the participants left St. Augustine following the 448th muster event to pay last respects to a fallen comrade at Camp Blanding.

When passing the parade field, take a moment to reflect on these deployments, reflect on the sacrifices made. And Give Thanks!

How the author got his story

Not every author includes four pages of acknowledgements, "Sacred Ground" author Greg Moore admits, but he "had a lot of people to thank."

Those include researchers across the country who helped him and family members of the fallen, who shared memories and history.

One of his best long-distance discoveries was made by an archivist at the University of Texas at Arlington who turned up a carte de visite, a type of photograph, of a painting made of Lt. John W.S. McNeil, who died at the age of 21 by the only shot fired when U.S. soldiers captured King Phillip in 1837 in Florida during the Second Seminole War.

The photograph was found in the papers of a family related to the McNeils, one of the numerous incidents of "six degrees of separation" Moore kept discovering.

"In the early days when there were fewer people, everybody really did seem to be connected to each other," he said.

He worked at the Guard, in his home office and at his "alternative office" at Beachcomber Restaurant, noting that his wife Nancy put up with his absences for four years as he wrote.

Numerous resources available through the Internet meant he could do a lot of research without ever leaving the office.

And he's quick to praise the inter-library loan system available through the St. Johns County Library System, which was able to help him find all but a couple of the 50-plus books he used in the research.

But it was families who added some of his best stories.

A stab-in-the-dark phone call led him to retired Maj. Gen. Selwyn D. Smith Jr. and stories of his military ancestors including Civil War soldier Sebree Smith, who buried three children in the cemetery. Two died while the family was posted to St. Augustine and the third died in an

accident while the family was at Fort Leavenworth. The family shipped the body back "rather than leave him alone in Kansas." The general and his son ended up coming to visit the cemetery and see the graves.

A post to a website led Moore to meet the brother of Reginald M. Deas, who died in Korea at the age of 16. Deas' brother Lee was a couple of years older and had earlier urged his parents not to let his younger brother enlist. It's not certain how Reginald Deas got in the service; his records were among millions burned during a fire in Missouri. But Lee Deas shared a photo of his brother and recalled him: "He was a damn good brother ... A scrapper. That's what he was."

Moore also met Gertrude Brown Mickler, who told him the story of her father, John Tenney Brown of Federal Point. Brown enlisted in the Florida National Guard before World War I and served overseas, making it to France for the last 43 days of the war.

The connections continue.

On Sept. 13, Mickler will be a guest of honor, representing her father, when the Florida National Guard holds the 448th anniversary of the First Muster.

The "first muster" took place on Sept. 16, 1565, when Pedro Menendez de Aviles assembled his soldiers and St. Augustine's civilian settlers to march on and capture the French settlement at Fort Caroline.

Proudly Welcomes

On Saturday September 28th, WW II Chief Boatswain Mate, Bill Ingram, US Navy ret., and ex Prisoner of War spoke at the Maritime Heritage Center at the Landing in Jacksonville. The presentation was hosted

by Paul Ghiotto, Curator of the Museum. Michael Rothfeld, President of FVPPI spoke about why Bill was chosen for the POW doc-

umentary, "Stolen Freedom" and Robert Mitchell of Rolling Thunder FL

Chapter 4 introduced and then led the discussion. Bill spoke about his incredible story of survival during his over three years of captivity by the Japanese in Burma. The Maritime Center provided drinks and refreshments and everyone in the audience was amazed by Bill's heroic story.

Historian spills local secrets of nation's bravest

On his way to writing a history of the Florida National Guard's St. Francis Barracks, Gregory Moore took a detour, ending up with a 245-page book on the St. Augustine National Cemetery on Marine Street.

It's an area he probably knows better than any other

living person. In his capacity as Guard historian he gives tours of the cemetery and talks about the history of the people there and of the Barracks, the site of the oldest military post in the United States.

"I love the position as historian here ... telling the history through the stories of the people here," Moore said.

As the Guard's former public affairs officer, he was the "de facto historian" before his retirement in 2001. Before he retired, he wrote a job description for a historian's post, one for a civilian.

Twenty-one people applied for the job, including several with doctorates. The 1974 West Point Army graduate ended up with the job. He was told "we know you know our history ... and you know the history of the National Guard. You won't have to get up to speed."

They also said he understood the job wasn't going to be 8 to 5 and would mean hours during holidays.

No problem for a career officer and the perfect niche for a man who can, without hesitation, recite the 15 lines of "In Flanders Field," a poem on honor and duty written in 1915 by Canadian Lt. Col. John McCrae after conducting the burial service for a soldier killed during a World War I battle.

Moore first recited it while in high school, learning it for a Veterans Day ceremony. Then, he remembers, there were lots of World War II guys (men his father's age), World War I guys (men his grandfather's age) and "the really incredible ones," men who had fought against Spanish troops in 1898.

"It's amazing to think I met men who fought in the Spanish-American War."

Even after he retired, Moore was able to go to the war in Afghanistan for a year, getting himself called back to service in public affairs with the Guard.

His book, "Sacred Ground: The Military Cemetery at St. Augustine," includes a

brief history of the grounds of the Florida National Guard Headquarters and focuses on 23 of the 2,800 men and women buried at the cemetery. The time period ranges from the War of 1812 to the Vietnam War.

His stories include a West Point graduate who resigned after a court martial, three children from one family who all died before the age of two, a Navy aviator killed while conducting a exhibition test flight, a Civil War prisoner of war who later served at Fort Marion (Castillo de San Marcos), a woman who was one of the first nurses in both the Army Nurse Corps (Female) and the Navy Nurse Corps (Female) and a St. Augustine soldier killed at the age of 21 in Vietnam.

Some of the people Moore knew personally — his father, Alvin A. Moore, one of the "Greatest Generation" which served in World War II, and his mentor and friend, Robert A. Hawk, who served in the U.S. Navy and later headed up the Historical Services Division of the Florida Department of Military Affairs.

On his deathbed in 2001, Hawk told Moore he wanted to be buried in the St. Augustine National Cemetery.

That, Moore told him, would be hard to do, but he promised to try.

The cemetery began reaching capacity by the late 1940s and there was no space by 2001. But, by a fluke, the officials at Bushnell were able to grant Hawk's request. A shrub had died near the cemetery gate and two small spaces small enough for urns were available. Hawk, who had been cremated, was buried where he wanted.

Last week Moore signed some of the first copies of his book after the annual Seminole War Commemoration hosted by the West Point Society of North Florida in August.

The Florida National Guard Foundation published the book and Moore will donate any profits to the foundation.

"It was a rush," Moore said. "I looked up and there were 31 people waiting in line for me to sign their book."

Army launches start of 50th Anniversary Commemoration of Vietnam War

The afternoon in the Pentagon auditorium Aug. 28 was a time for reflection on a war that spanned 10 years and cost the country the lives of more than 58,000 young men and women. It was also an occasion to honor and thank nine Vietnam War veterans who served a total of 14 tours in-country and 225 years in uniform.

Kicking off the Pentagon's first event commemorating the 50th anniversary of the conflict, Lt. Gen. Raymond Mason, Army G-4, opened the ceremony recalling personal memories as well as his broader experiences as a young American citizen.

"I was a young Army brat and it was difficult for me to watch my dad come back after his third tour in Vietnam and not get treated appropriately, at least in my mind," he said. "I was just a pretty young guy at that time, but I could feel that it wasn't right. It struck me, and I knew if I ever had the opportunity to make that right I would do the best I could.

"Today, we are recognizing nine of our patriots and their families who stood up to the test of their generation and their decade," Mason continued. "I think it's well overdue. Nothing is more important than pausing and reflecting on the sacrifices of what these great men and women did and those who gave their last full measure."

On March 8, 1965, America's ground war in Vietnam began when 3,500 Marines were deployed with the American public's support. By Christmas, nearly 200,000 Soldiers, Marines, Airmen and Sailors were in the country. At war's end on April 30, 1975, nearly 3 million Americans had been on the ground, in the air and on rivers of Vietnam. More than 58,000 Americans lost their lives.

While the official 50th anniversary of the War will be in 2015, the president and Congress requested the secretary of Defense to begin planning the Vietnam War commemoration in 2007.

The goal is to get more than 10,000 corporations, civic groups as well as government and community organizations to join as partners and help sponsor hometown events to honor Vietnam veterans, their families and those who were prisoners of war and missing in action.

To date, 4,921 commemorative partners have signed on, including Army G-4, which became the first.

Following Mason's remarks, Vice Chief of Staff of the Army Gen. John Campbell thanked him and his team for leading the way for the rest of the nation to celebrate over the next few years the contributions of Vietnam veterans.

Son of an Air Force senior master sergeant, Campbell told of his years growing up on military bases around the world before attending West Point, and then recalled his first interaction with Vietnam veterans while a lieutenant in Germany.

"Both the battalion commanders were Vietnam veterans ... all the platoon sergeants, all the first sergeants, all the company commanders were Vietnam veterans," he said. The vets instilled in him their hard-fought lessons-learned from Vietnam and wanted to make sure the young lieutenants and Soldiers wouldn't make the same mistakes they had, he added.

Former G-4 and now retired Lt. Gen. Claude "Mick" Kicklighter serves as director of the U.S. Vietnam War Commemoration. During the event he previewed the timeline of plans for honoring Vietnam veterans across the country over the next few years.

"Veterans of Valor," a 30-minute documentary with the nine honorees recalling humorous and somber anecdotes of their war experiences and interspersed with still photographs of themselves in Vietnam was also premiered.



A break for disabled vets, current military


It's modest compensation for their sacrifice, but disabled veterans and current military personnel will be exempt from certain hunting and fishing license requirements in Florida.

JACKSONVILLE, Fla. -- Freddie Woodard says it's been at least 15 years of feeling "ashamed." He says his teeth have been so bad he was embarrassed to open his mouth. But today at the Healing Hands Clinic Freddie got his new teeth.



He looked in the mirror and just beamed. "Thank you, God!" he kept saying.

Freddie knows without dental insurance that the cost for his dental care was out of reach. Even though he's a veteran, he does not have financial help for dentistry.

Healing Hands staff says they have about 20 veterans on the waiting list right now. They say unless a veteran is 100% disabled, dental is not covered.

So Freddie was facing the rest of his life without functioning teeth. His bill from a regular dentist would have been around \$5,000.

Volunteer dentist Dr. Dwight Jones says just seeing Freddie smile is worth the volunteer hours he puts in at the clinic.

But the Healing Hands clinic provided both upper and lower teeth for Freddie. Volunteer dentists couldn't save a single one of his teeth. They were all in such bad shape.

Freddie is thrilled. He even got a few tears in his eyes today.

However, the waiting list for Healing Hands dental care topped 500 going into this week. Since just this past Tuesday, dozens more have signed up to try and get free help.

The clinic is too small.

That's why we're doing the Apple Project. We're trying to build a free dental clinic which could serve thousands of people.

Veterans history project at St. Johns County libraries

VETERANS HISTORY PROJECT

eterans who have a story to tell and who would like to record it for future generations are encouraged to contact the St. Johns County Public Library System and participate in the Veterans History Project.

It is through personal narratives, correspondence and visual materials that the Veterans History Project is able to collect, preserve, and make accessible the personal accounts of American veterans so future generations can better understand the realities of war. The Congress created the Veterans History Project in 2000 as part of the American Folklife Center at the Library of Congress. The St. Johns County Public Library System partnered with Haven Hospice in 2012 to offer this oral history service to local veterans.

The project collects first-hand accounts of U.S. Veterans from World War I (1914–1920), World War II (1939–1946), the Korean War (1950–1955), the Vietnam War (1961–1975), the Persian Gulf War (1990–1995), and the Afghanistan and Iraq conflicts (2001–present), as well as those serving in the armed forces during the years between these conflicts.

After veterans are matched up with a volunteer interviewer for approximately an hour, they not only will obtain their own personal copy, but they can elect to send their recorded account to the Library of Congress in Washington, D.C. If desired, the veteran can request a copy be kept in the St. Johns County Library System, have it posted online for others to easily access, or both.

The Veterans History Project relies on volunteers to interview, record, compile and donate materials. Veterans, civilians, adults, young people, scholars, students, amateurs, and experts are all encouraged to participate. The Wall

The source for this information is unknown as is its accuracy.

A little history most people will never know. Interesting Veterans Statistics off the Vietnam Memorial Wall

There are 58,286 names now listed on that polished black wall.



The names are arranged in the order in which they were taken from us by date and within each date the names are alphabetized. It is hard to believe it is 36 years since the last casualties.

The first known casualty was Richard B. Fitzgibbon, of North Weymouth, Mass. Listed by the U.S. Department of Defense as having been killed on June 8, 1956. His name is listed on the Wall with that of his son, Marine Corps Lance Cpl. Richard B. Fitzgibbon III, who was killed on Sept. 7, 1965.

There are three sets of fathers and sons on the Wall.

39,996 on the Wall were just 22 or younger.

8,283 were just 19 years old.

The largest age group, 33,103 were 18 years old. 12 soldiers on the Wall were 17 years old.

5 soldiers on the Wall were 16 years old.

One soldier, PFC Dan Bullock was 15 years old.

997 soldiers were killed on their first day in Vietnam ..

1,448 soldiers were killed on their last day in Vietnam ..

31 sets of brothers are on the Wall.

Thirty one sets of parents lost two of their sons.

54 soldiers attended Thomas Edison High School in Philadelphia . I wonder why so many

from one school.

8 Women are on the Wall. Nursing the wounded.

244 soldiers were awarded the Medal of Honor during the Vietnam War;

156 of them are on the Wall.

Beallsville, Ohio with a population of 475 lost 6 of her sons.

West Virginia had the highest casualty rate per capita in the nation. There are 711 West Virginians on the Wall.

The Marines of Morenci - They led some of the scrappiest high school football and basket-ball teams that the little Arizona copper town of Morenci (pop. 5,058) had ever known and cheered. They enjoyed roaring beer busts. In quieter moments, they rode horses along the Coronado Trail, stalked deer in the Apache National Forest. And in the patriotic camaraderie typical of Morenci's mining families, the nine graduates of Morenci High enlisted as a group in the Marine Corps. Their service began on Independence Day, 1966. Only 3 returned home.

The Buddies of Midvale - LeRoy Tafoya, Jimmy Martinez, Tom Gonzales were all boyhood friends and lived on three consecutive streets in Midvale, Utah on Fifth, Sixth and Seventh avenues. They lived only a few yards apart. They played ball at the adjacent sandlot ball field. And they all went to Vietnam. In a span of 16 dark days in late 1967, all three would be killed. LeRoy was killed on Wednesday, Nov. 22, the fourth anniversary of John F. Kennedy's assassination. Jimmy died less than 24 hours later on Thanksgiving Day. Tom was shot dead assaulting the enemy on Dec. 7, Pearl Harbor Remembrance Day.

The most casualty deaths for a single day was on January 31, 1968 ~ 245 deaths.

The most casualty deaths for a single month was May 1968 - 2,415 casualties were incurred.

For most Americans who read this they will only see the numbers that the Vietnam War created. To those of us who survived the war, and to the families of those who did not, we see the faces, we feel the pain that these numbers created. We are, until we too pass away, haunted with these numbers, because they were our friends, fathers, husbands, wives, sons and daughters. There are no noble wars, just noble warriors.





VA Announces Award of Patient-Centered Community Care Contracts

Contracts Provide Expanded Access to Community-based Care



WASHINGTON (Sept. 19, 2013) -- The Department of Veterans Affairs announced today that Veterans will have greater access to quality health care through a new initiative: Patient-Centered Community Care (PCCC).

"PCCC is an innovative solution that helps VA medical centers continue to provide quality care efficiently," said Secretary of Veterans Affairs Eric K. Shinseki. "This will be a valuable option for VA medical centers to use to expand our Veterans' access to care."

Under PCCC, VA medical centers will have the ability to purchase non-VA medical care for Veterans through contracted medical providers when they cannot readily provide the needed care due to geographic inaccessibility or limited capacity. Eligible Veterans will have access to inpatient specialty care, outpatient specialty care, mental health care, limited emergency care, and limited newborn care for enrolled female Veterans following the birth of a child.

"PCCC provides a regional contracting vehicle for VA to work with local community providers to give Veterans access to high quality care," said Dr. Robert Petzel, VA's Under Secretary for Health. "It will also help VA in our continued efforts to ensure timely and accessible services are provided to Veterans for non-VA medical care."

In total, VA has awarded two contracts under PCCC, one to Health Net Federal Services LLC and another to TriWest Healthcare Alliance Corp. These companies will set up networks in six regions covering the entire country. VA expects to have these regional contract networks available to its medical centers by the spring of 2014. The awarded contracts, estimated at \$9.4 billion, include one base year and four option years.

PCCC is part of the overall Non-VA Medical Care Program. It will provide all VA facilities with an additional option to purchase non-VA medical care when required Veteran care services are unavailable within the VA medical facility or when the Veterans benefit from receiving the needed care nearer to their homes.

Among the many benefits to the Veterans and VA under these new contracts, VA will enjoy standardized health care quality metrics, timely return of medical documentation, cost avoidance with fixed rates for services across the board, guaranteed access to care, and enhanced tracking and reporting of non-VA medical care expenditures over traditional non-VA medical care services.
