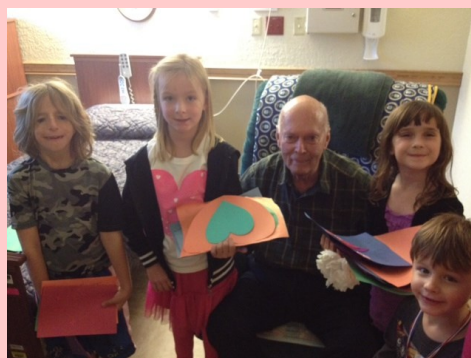

St. Augustine, Fla, (January 29, 2014) – Every January The Veterans Council of St. Johns County presents the Col. Ed Taylor “Veteran of the Year” award to an outstanding individual or organization for exceptional work on behalf of the veterans of St. Johns county. This year’s recipient is undeniably the hardest working veteran in the county.

"Joseph McDermott epitomizes the meaning of that term," said Ray Quinn during the Wednesday night meeting. Known to everyone as “Mac”, McDermott is the Senior Veteran Service Officer for the Veterans Service Office in St. Johns County. McDermott and his staff assist veterans from all services with filing of claims with the Veterans Affairs.

"Besides overseeing the office and staff," continued Quinn, "McDermott is present at many of the veteran organization meetings to brief the membership on what is happening with the claim process at the present time." "He attends many of the County Board of Supervisors meetings, meets with county staff on a myriad of areas, especially the move to offices within the new Health and Human Services building dubbed the 'Gauze Mahal'."

The award was presented to McDermott by Col. Ed Taylor, name-sake of the award and co-founder of the current council.

With elections behind them, members of the Veterans Council of St. Johns County geared up for a new year of activity.

Officers for 2014 are Bill Dudley, Chairman; Ray Quinn, Vice Chairman; Michael Rothfeld, Treasurer; George April, Secretary.

Guest speakers for the evening were Theresa Andrews and Karen Burns representing EPIC Behavioral Healthcare. Andrews and Burns briefed the council about the new expanded facilities and how the organization can assist veterans dealing with mental health and substance abuse issues. With the advent of their new facility, residents of St. Johns County will have local access to care and not have to travel to other counties for help.

Dwyn Taylor spoke about upcoming events of Youth Leadership program of the St. Johns County Chamber of Commerce. “The young people of the program will be the leaders of future generations,” said Taylor. “Veterans, as well as business, must nurture them to instill good leadership.”

The Jacksonville Ladies

The Jacksonville Ladies started out as a group from the Navy Wives Club and has evolved into a very dedicated group of women whose husbands, sons and fathers, from all the branches of services that have served our country. Membership is strictly voluntary and is open to all who have a sincere desire to pay final tribute to our Veterans and offer condolences to their families.

A Jacksonville Lady has been present at every internment since the first internment at Jacksonville National Cemetery on January 7, 2009. Since that day there has been over 6,000 internments.

The Jacksonville Lady is not there to intrude, but to stand as a silent witness and give honor to the Veteran and offer condolences to the family.

This is not a typical volunteer job, it must come from the heart with the thought that it is an honor to give back to those who have given so much to preserve the freedoms we enjoy today.

The only requirements are compassion and a sincere desire to honor our Veterans, especially those with no family present, so they are not laid to rest without someone there who honors their service and sacrifice.

Cliff Shields was named Director of Jacksonville National Cemetery, effective Oct. 7, 2013. As director, he is responsible for all administrative, maintenance and burial operations.

Prior to this appointment, Mr. Shields was director of Santa Fe National Cemetery from January 2009. He also served as director of Fort Smith National Cemetery in Arkansas from March 2008.



He was the acting director of Fayetteville National Cemetery in Arkansas from June 2008, and from September 2007 through March 2008, he served as the assistant to the director of South Florida National Cemetery, where he played a pivotal role in helping to open the new national cemetery in Lake Worth, Fla.

Mr. Shields graduated from the comprehensive year-long Cemetery Director Intern Program in August 2007. He was a cemetery caretaker and then a cemetery representative from 2001 to 2006 at Biloxi National Cemetery in Mississippi. He was one of two employees who reported to work immediately following Hurricane Katrina, and devoted a great amount of time and assistance to the relief effort, for which he was honored with the VA Secretary's Hero Award.

Prior to joining NCA, Mr. Shields served in the hospitality industry for 30 years travelling throughout the U.S. on various assignments before retiring in 2001.

Mr. Shields attended the University of Southern Mississippi in Hattiesburg and then joined the U.S. Army for three years. He served in Vietnam from 1968 to 1969 with the 199th Light Infantry Brigade. Upon completion of his military service, he returned to the University of Southern Mississippi in 1970 to further his studies in business management.

THE BEACHES VETERANS MEMORIAL PARK UNVEILS THEIR NEW CREST HONORING ALL MILITARY SERVICES



Beaches Veterans Memorial Park Inc. President, Clarence Hill, unveiled the new veterans organizational crest during their February 18 Board Meeting. It recognizes the six Military Services who participated during WW 11, and the Chaplains Regimental Crest, honoring 340 Chaplains, including three Congressional Medal of Honor winners. These are the Chaplains, who gave their lives in combat operations since the Revolutionary War. Of the six services, is that of the US Merchant Mariners who were attached to the USN during the war, They lost over 9300 mariners and suffered a greater percentage in war related deaths than all of the military services combined.

In 2010 the six Beaches veterans organizations combined to form the BVMP Inc, to develop park land provided by the City of Atlantic Beach for a Veterans Memorial Park. Its purpose is to hold patriotic ceremonies for the community, and to bring honor to the US Armed Forces, past and present. A Chaplains Memorial Garden has been added honoring the 340 Chaplains that have been killed in combat operations. Included in this Garden is the 'Path of Honor' wherein resides the inscribed bricks of these men, along with those of local individuals being honored by family and friends. Scamming our veterans

Former Veterans Council Chair Tom Waskovich, a retired Army Major, was shopping at the Anastasia Island Winn Dixie when he saw a group collecting money in front of the store with a sign, "Support our Veterans, United we Stand."

"I asked if they were veterans and where were they from, and did they check with our Veterans Council," says Waskovich. "They responded that they were not veterans, they were from Tampa, and they had not checked with anyone locally except the store manager. As far as they knew no money was going to our county veterans.

"I strongly expressed my displeasure and decided to remain and advise any store customers not to give them any money. After about 10 minutes they packed up and left the area.

"The store manager said he thought they were working for local veterans and that he would not let them return. He said it would be fine if only groups authorized by the Veterans Council would be allowed to solicit there."

Waskovich has urged the Veterans Council to send letters to all the food stores in the county that only groups that have an authorized letter from the Veterans Council be allowed to solicit money at their stores.

Veterans Council Chair Bill Dudley added, "In looking at the organization's 990 tax filing for last year I noted that the President of VSO (Veterans Service Organization) had a salary of \$286,711. All of our Veterans Council members are non-compensated volunteers who give freely of their time to support veterans and their needs.

"It is also important to know that Florida law makes it a third degree felony to solicit for charitable contributions while misrepresenting as veterans or for veterans' purposes."

Tampa Rough Riders Pay Tribute By Michael Isam



St. Augustine, Fla, (February 23, 2014) – “SACRED to the MEMORY of all the OFFICERS and SOLDIERS killed in BATTLE and died on SERVICE during the FLORIDA WARS” reads the inscription of the north face of the Florida Wars obelisk located in the St. Augustine National Cemetery.

A single rose placed at the base of that face spoke volumes of one person’s love and respect for the sacrifice of a few, for the good of the many.

The 1st U.S. Volunteer Cavalry Regiment "Rough Riders," Inc. dispatched an expeditionary force to St. Augustine on Friday morning. The force and guests enjoyed a champagne reception and buffet later in the evening.

At noon on Saturday, the force performed a wreath laying ceremony on the grounds of the St. Augustine National Cemetery honoring Rough Riders and others who served and sacrificed for their country.

Among the 1218 graves in the cemetery, 3 received special wreaths. At the pyramids on the south end a wreath was placed to honor the Major Dade command. On the west side, tribute was paid to Rough Rider Robert McNeal. On the east side, a wreath was placed to honor the final resting place of Buffalo Soldier James Nelson.

The “Rough Riders” were an all cavalry regiment raised in 1898, by Theodore Roosevelt when the United States declared war on Spain, April 25th, after a riot in Havana, Cuba. The U.S. sent the battleship Maine to Cuba to protect American interests. The sinking of the ship by an "external explosion of unknown origin", was the spark that started the Spanish American War.

According to information from the Woods & Wonton Chapter, Inc. Buffalo Soldiers website, Tampa was the embarkation point for the Rough Riders.

Among the assembled ten regiments were two black units camped on the fringes of the elegant Tampa Heights neighborhood. The Twenty-fourth Infantry was located to the north, while the Twenty-fifth camped to the southeast. While the Buffalo Soldiers fostered pride among local blacks they encountered much hostility in Tampa.

On the eve of the army's embarkation for Cuba, Tampa was the scene of a serious clash between the black and white troops. Overcoming racial obstacles, the Buffalo Soldiers distinguished themselves on the battlefield in Cuba and later in the Philippines, earning five Medals of Honor for valor at San Juan and El Caney.

In 1835, 110 US troops under the command of Major Francis Dade were ambushed between Fort Brooke (Tampa) and Fort King (Ocala) near present day Bushnell. Only 2 men survived. The bodies of Major Dade and his men were reinterred in this cemetery in 1842.

The St. Augustine National Cemetery is dominated by three eight-foot coquina pyramids and a 20-foot obelisk. The Dade Pyramids lay atop the remains of over 1300 US soldiers who died in the 1st

and 2nd Seminole Wars. The obelisk was erected in 1881 as a tribute to Major Dade and his troops.

Speakers at the event included Mr. Cliff Shields, Director of Jacksonville and St. Augustine National Cemeteries; Mayor George Gardner, past mayor of St. Augustine; LTC. Bill Moline, USAF (Ret.); and B.G. Charles Spicola, Rough Riders

Each spoke about the history of St. Augustine, the role of Florida in war time and the dedication of service members to a cause greater than themselves.

The ceremony was concluded with a volley by the Rough Riders Honor Guard, TAPS presented by LTC Will Crenshaw, USA (Ret.), followed by the placing of the wreaths and a salute to each memory.

All were invited to American Legion Post 37 for a delightful repast.

Vets mount offensive on War Memorial move

St. Augustine's veterans' organizations are advancing their plan to move "the city's most sacred memorial" to the west garden of Government House rather than the currently approved plan to move it 35 feet from a corner of the Plaza de la Constitución to a more central plaza location.

Retired U.S. Army Col. Rik Erkelens, Military Officer's Association president and 450 Military Committee chair for the setting of three replica cannons in Oglethorpe Battery Park last summer, describes a plan to reset the memorial in the center of Government House's west garden with a backdrop of shields of the five military services along an existing wall.

"There is no greater love a man has for his country than to lay down his life for it," Erkelens says. "We are judged by the manner in which we honor our heroes. This site will provide that singular honor."

To reverse recent City Commission approval of a move within the Plaza, the veterans "are working closely with the pilot club which placed the monument in its present location in 1946" and enlisting the help of the University of Florida, manager of the state-owned Government House property. They'll be up against sentiments such as Vice Mayor Nancy Sikes-Kline, who said, "I can think of no more honored place than putting (the memorial) in the central plaza."

With such a move, Erkelens envisions a ceremonial next year, St. Augustine's 450th anniversary: "Veterans organizations will conduct an appropriate re-dedication and parade of colors from the National Cemetery to the memorial on Memorial Day 2015."

Vets stand down on memorial move: Memorial fund to be established

Urging that veteran organizations and the Military 450 Committee "be in on the original planning on anything that touches our military," retired Colonel Rik Erkelens acknowledged Monday the process of moving the War Memorial within the Plaza de la Constitucion had gone too far to change the City Commission's mind and move it to the west garden of Government House.

At that commission meeting, General Services Director Jim Piggott said a contractor has offered to donate his services to move the memorial a planned 35 feet toward the center from a corner of the Plaza where it's hidden by electric panels.

And commissioners quickly endorsed Commissioner Don Crichlow's suggestion that a maintenance fund be established for the city's memorials and monuments. He suggested a third of the new franchise fee monies in the recently approved ticket increase for Old Town Trolleys could be committed. It could amount to \$ 9,000 annually.

Piggott said more than \$ 10,000 in donations to cover anticipated cost of moving the War Memorial can be used for additional memorial plaques and the balance put in such a memorial fund.

Col. Howard McGillin, Jr. serves as legal counsel to the chapter.

Conducting the installation was Jim Conner, president of the Florida Council of Chapters.

ORLANDO: Veterans Affairs officials have told U.S. Senator Bill Nelson that they're ready to break ground on a national simulation center to train doctors and nurses in the latest procedures for veterans' illnesses and injuries.

Nelson's office said in a statement that the \$ 20 million facility would be near the Orlando VA Medical Center, which is currently three years behind in opening. It will provide medical professionals anywhere in the world with access to research and training.

The senator has been told that the new center is set to begin construction in April, with completion in 15 months.

Nelson is a senior member of the Senate Armed Services Committee, which sought funding for the project.

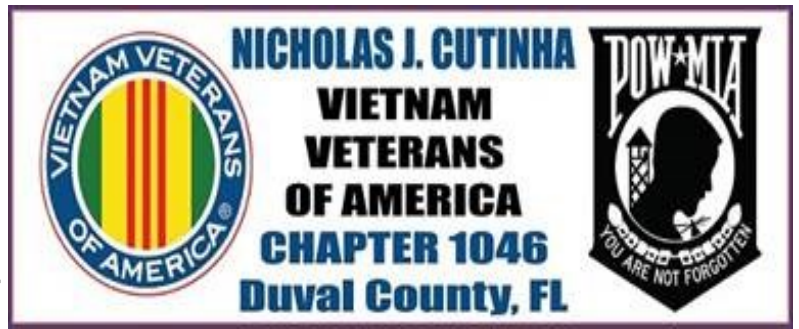
WELCOME HOME!

Upcoming Exempt Organization Filing Dates

The following dates apply to all Exempt Organizations. Those which have a fiscal (business) year that does not end on December 31 (aka "Calendar Year Taxpayers") may have a later deadline for their "tax year". For 990 filings, the months after tax-year-end are noted:



January 31 Provide Forms 1099-MISC to any one person or business receiving \$600 or more from your exempt organization (most corporations and certain other transactions actions are exempt). See IRS instructions at <http://www.irs.gov/pub/irs-pdf/i1099gi.pdf>

February 28: File Forms 1099-MISC (for total payments of \$600 to any one person or business or more made in prior calendar year—most corporations are exempted) together with Form 1096 with the IRS.

May 1: File Florida Corporate Annual Report with the Florida Secretary of State (on-line at www.sunbiz.org). Does not apply to associations (unincorporated affiliates of a parent exempt organization).

May 15: Complete IRS 990 filing:

1. If your exempt organization has less than \$50,000 in gross receipts (the total amounts the organization received from all sources during its tax year, without subtracting any costs or expenses.), you may file your 990-N (e-postcard) on-line at <http://epostcard.form990.org/> .

2. Prepare 990-EZ if your exempt organization has less than \$200,000 in gross receipts and less than \$500,000 in total assets at tax-year-end. A complete 990-EZ filing includes appropriate related schedules.

3. Prepare 990 if your exempt organization does not meet the above criteria.

Non-calendar year organizations file by the 15th day of the 5th month after close of the tax year.

Annually: All charitable organizations and sponsors must register prior to engaging in solicitation activities in Florida, and renew annually. The expiration date for charitable organizations and sponsors is one (1) year from the initial date of compliance with registration requirements.

Prepare your organization's Solicitation of Contributions Registration Application <http://forms.freshfromflorida.com/10100.pdf> and file not later than the expiration date on file with the Florida Department of Agriculture and Consumer Affairs. 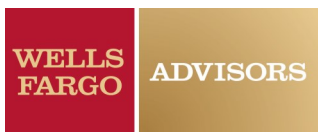
